

**MINUTES OF THE ANNUAL GENERAL MEETING OF
SHAREHOLDERS MERUS N.V.**

May 21, 2025

Minutes of the annual general meeting of shareholders of Merus N.V., a public limited liability company (*naamloze vennootschap*) incorporated under the laws of the Netherlands, having its corporate seat at Utrecht, the Netherlands (the "**Company**"), held on May 21, 2025 at 15:00 pm (CEST) / 9:00 am (ET) at the offices of NautaDutilh N.V., Beethovenstraat 400, 1082 PR Amsterdam, the Netherlands (the "**Meeting**").

The Meeting was attended by among others Non-Executive Director Anand Mehra, Bill Lundberg, President and Chief Executive Officer of the Company, Peter B. Silverman, the Company's EVP, Chief Operating Officer and General Counsel and Elodie Smit, candidate civil law notary and Paul van der Bijl, civil law notary in Amsterdam and legal counsel to the Company.

The Meeting had been convened with due observance of all relevant provisions of applicable law and the Company's articles of association.

At the Meeting, for all agenda items (except for agenda item 5) 57,735,352 shares in the company's capital were represented, representing approximately 83.45% of the company's issued share capital. At the Meeting, for agenda item 5, 61,712,250 shares in the company's capital were represented, representing approximately 89.20% of the company's issued share capital.

The attendees of the Meeting indicated that they had no questions or comments with respect to the items included on the agenda for the Meeting.

After having put all voting items on the agenda for the Meeting to a vote, it was concluded that all voting items on the agenda were passed by the requisite majority.

The Meeting was closed.
